TYRE HOUSE

Location:

The Tyre House is located at 220 South 341, Odum, Wayne County, Georgia. It is on the southwest side U.S. Highway 341, southeast of Carter Street.

Significance:

The Tyre House is historically significant a c. 1938 bungalow house type located within the town of Odum. It contributes to an understanding of the residential development of this early twentieth century railroad town.

Description:

This one story frame residence displays a front gable roof, full facade front porch with battered columns on brick piers, galvanized steel cladding, two front entrances, exposed rafters and vertical two over two windows. The interior exhibits a linear floor plan without hallways (a floor plan is attached). Interior materials include tongue and groove ceilings and walls, five panel doors, and linoleum and wood plank floors.

History:

The Tyre House was constructed c. 1938. Leila Tyre, the current owner, purchased the 35 by 209 foot tract from Mrs. Ruby Bethune on October 11, 1952 (Wayne County Deed Book 70, page 295). Mrs. Bethune purchased the house from J.R. Garner on February 13, 1950 (Deed Book 65, page 305). Garner acquired the house from Douglas Carroll on November 27, 1943 (Deed Book 59, pages 523-24). Carroll had acquired the house four months earlier, on July 14, 1943 from G.D. Morgan (Deed Book 59, page 105). The Morgans had purchased the tract from Massey Roberson on August 21, 1941 (Deed Book 57, page 334). The Robersons had purchased the tract of land on which this house is located from W.M. Odum on April 8, 1910 (Deed Book 29, page 380).






