Significance: The Raynold's Pass Rest Area is significant for its association with the Montana Department of Transportation's (MDT) development of roadside rest areas during the 1960s. The department developed a standard design for rest areas, including landscaping, and this site is representative of that standard design. The MDT located many rest areas at scenic areas in Montana to encourage users to stop and spend time at them. The Raynold's Pass Rest Area is representative of the type of rest area established along the state's two-lane highways. While many of the features located at the site are not historic, they still reflect the MDT's philosophy for this type of facility in the late twentieth century.

HISTORY

The provision for picnic shelters are Montana Department of Transportation rest areas was specified in the 1958 American Association of State Highway Officials' *A Policy on Safety Rest Areas for the National System of Interstate and Defense Highways*. Ironically, however, the MDT had been building roadside picnic areas with picnic tables and shelters since 1934. It is not known who devised the basic MDT rest area picnic shelter, but its location within the rest area was determined by landscape designer William Schweyen sometime after his employment by the MDT in October 1962.¹

PICNIC TABLE SHELTER 1

A. DESCRIPTION

Picnic Table Shelter 1 is an 11' x 15' concrete pad covered by a flat roof supported by six 8" x 8" wood beams. The roof is 7' 8" above the concrete pad. The shelter is of open post and beam construction and the roof is sheathed in corrugated metal. The roof joists are exposed. The concrete pad is oriented north to south and is located approximately 40' northwest of the parking lot (MT-148-A) and 72' west of the restroom building (MT-148-B). The shelter currently covers two non-historic picnic tables.
