Summary: United States Navy officer. Chiefly Christie's official correspondence as a commander of submarines during World War II. Includes material relating to Christie's efforts to have a medal of honor awarded to submarine commander Samuel David Dealey.

Scope and Content Note

The papers of Ralph Waldo Christie (1893-1987) span the years 1941-1945 and consist primarily of Christie's official correspondence while serving as commander of submarine squadron five, 1941-1942, and as commander of submarines, Southwest Pacific force, seventh fleet, 1943-1945. The correspondence is arranged chronologically. Also included are correspondence, newsclippings, and an essay concerning Christie's efforts to have a medal of honor awarded to Samuel David Dealey, the commander of the submarine *Harder*. The submarine and its commander were lost in action in 1944.
