1810, Aug. 24	Born, Lexington, Mass.
1831	Graduated, Harvard College, Cambridge, Mass.
1836	Graduated, Harvard Divinity School, Cambridge, Mass.; joined the Transcendental Club
1841	Presented a sermon, "A Discourse on the Permanent and Transient in Christianity," doubting that the scriptures of historic Christianity reflected the truth
1846	Installed as minister of the 28th Congregational Society of Boston, Mass., a "free church" congregation that included Louisa May Alcott, William Lloyd Garrison, Julia Ward Howe, and Elizabeth Cady Stanton
1846-1848	Opposed the Mexican War
1848-1851	Edited <i>Massachusetts Quarterly Review</i>
1848	Wrote <i>To a Southern Slaveholder</i> , in opposition to slavery
1850	Advocated violating the Fugitive Slave Law of 1850
1859	Helped finance John Brown's failed slave insurrection in Virginia
1860, May 10	Died, Florence, Italy

Scope and Content Note

The papers of Theodore Parker (1810-1860) span the years 1838-1910, with the bulk of the material concentrated in 1850-1860. The collection consists of correspondence, writings, poetry, and printed material relating to Parker's antislavery lectures and to the publication of his biography and collected writings, including transcripts by others and reminiscences of him. Correspondents include James Gillespie Birney, E. P. Clark, Rufus Leighton, Horace Mann, Oliver Johnson, F. B. Sanborn, and Parker's wife, Lydia Dodge Cabot Parker.
